NOW, THEREFORE, upon the recommendation of the Superintendent of Schools, the Board of Education hereby approves the execution of a correction deed to rectify the inadvertent omission and achieve the parties' intention, and authorizes the Board President to sign a correction deed, as reviewed and approved by District counsel, and any other documents necessary in order to record the same.
