Jeff Beecher of Jenkins, Beecher & Bethel reviewed the 2019-2020 Independent Audit. Overall a good audit though the district is over the 4% of unappropriated fund balance allowed by the state. He discussed the district's financial statements. Discussion on money remaining in the capital projects was held. He will get clarification and see how much is left. Motion by Mr. Erickson, seconded by Mr. Freebern to accept the 2019-2020 Independent Audit.

Mr. Lail discussed investing in a money market account at Glens Falls National Bank that would allow the district to make interest at a higher rate than the current investment account. Mr. Lail reports that Glens Falls National works with multiple banks so the entire investment is collateralized.

Mrs. French reports the Building and Grounds Committee held a workshop regarding the Capital project and how best to proceed. The Board discussed completing what we can now including the elevator, LED lighting and welding projects then rebidding site work contingent on voter approval for additional funding.

Gallo Construction Bid accepted Motion by Mrs. LaGuerre, seconded by Mr. Freebern to accept the bid from Gallo Construction for the General Construction Contract of the North Warren capital project in the total amount of \$234,200. (base bid at \$217,000. add Alternate #2 \$17,200).

Hewitt Young Electric, LLC bid accepted Motion by Mr. Erickson, seconded by Mrs. Hill to accept the bid from Hewitt Young Electric, LLC for the Electrical Work Contract of the North Warren Capital project in the total amount of \$92,700. (base bid of \$34,500, add alternate #1 \$53,000. and add alternate #2 \$5,200.)

T. McElligott Bid accepted Motion by Mr. Freebern, seconded by Mr. Erickson to accept the bid from T. McElligott, Inc. for the Mechanical work contract of the North Warren Capital project in the total amount of \$149,000.(base bid of \$104,000. and add Alternate #2 \$45,000.)

Mrs. French shared the new protocols for winter sports in 20-21. Low risk sports could potentially being on December 14 while high risk sports could star January 4. The Board agreed that North Warren would have a winter sports season if approved by the league and Section.

Mrs. French reports letters will be mailed to remote learners requesting their decision for the remainder of the school year. The reply must be returned by December 14 if they are planning to go in person or continue remote learning for the remainder of the school year. Mrs. French thanked Mr. Dexter and the BOCES staff for their support during the COVID cases. The health-screening questionnaire has been updated for everyone. Remote learning was discussed.

Mr. Lail reports the audit and reports for last year are all complete. The budget process has begun and the district had no state aid cuts in November.

Mr. Martin reports the January regents are cancelled and the first marking period is ending on Friday (11/20).

Mrs. Kelly reports the district received a generous donation from Son Rise Lutheran Church of Halloween candy (all individually wrapped). The District recently celebrated Unity Day.

Mrs. French discussed remote learning and sports. Remote students must be in attendance in the remote classes to play sports.

Mr. Maday would like to see the tanks in a surplus sale.
