Motion by Mr. Erickson, seconded by Mr. Freebern to approve the agenda changes.

Motion by Mr. Erickson, seconded by Mr. Freebern that upon recommendation of the Superintendent, Valerie DeLuca who is Permanently certified in Special Education is hereby appointed to the non-probationary position of long-term substitute to fill a leave of absence effective September 1, 2022 to December 22, 2022. Mrs. DeLuca will be appointed on Step 1 of the NWTA contract.

Ms. Towers will be appointed on Step 1 of the NWTA contract.

Ms. Jackson will be appointed on Step 1 of the NWTA contract. This service will not be credited toward tenure or seniority.

Motion by Mr. Erickson, seconded by Mr. Freebern that upon recommendation of the Superintendent, Allison Dix who is Initially certified in Childhood Education (Grades 1-6) is hereby appointed to the temporary position of Elementary Teacher from September 1, 2022 and ending June 30, 2023. Ms. Dix will be appointed on Step 1 of the NWTA contract. This service will not be credited toward tenure or seniority.

Motion by Mr. Freebern, seconded by Mr. Erickson that upon recommendation of the Superintendent, Andrew Peryer who *will be* Initially certified in Music is hereby appointed to the position of Music Teacher in the Music tenure area for a probationary period commencing on September 1, 2022 and anticipated to end on August 31, 2026. Mr. Peryer will be appointed on Step 4 of the NWTA contract.
